You Should Join: Because your participation and generous support last year, enabled us to provide free legal services to human trafficking survivors that they would otherwise not be able to afford and resulted in the following highlights.

- In conjunction with Amara Legal Services based in Washington, D.C. and Regent University Law School Clinic (the "Clinic"), we were able to provide free legal services to human trafficking survivors in Northern Virginia, Southeastern and Central Virginia in a number of legal areas including family law, victim witness advising and protection of rights, vacatur and expungement of criminal records, help with credit and debt collection issues and criminal defense. This included the first successful survivor Vacatur petition in Virginia in conjunction with the Clinic.
- We continued partnerships and collaboration through our participation and development of the Regional Disciplinary Collaborative ("The RIC:") for Region III of HHS encompassing Delaware, Maryland, Pennsylvania, Virginia, West Virginia, and Washington, D.C., and the Richmond Regional Human Trafficking Collaborative.
- Provided education, training, and guidance on human trafficking to community groups and mandatory reporters.
- Was interviewed by various newscasts, print, and social media sources regarding human trafficking and the legal issues facing survivors in various venues around Virginia including NOVA, Richmond, and Greater Hampton Roads. as well as what individuals can do to combat this evil and support the work of our organization.

With your partnership in 2024, we will be able to continue these efforts and expand the work to serve even more survivors.
